Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2023-24 was £9.93 per elector.

Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Acton Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

Reconciliation of the accounts

One of our core audit tests is to ensure that the Accounting Statement agrees to the underlying records. Our testing identified the following items that we were not able to fully agree back to the cashbook:

Item	Discrepancy
Line 3 Other receipts	£8.27
Line 4 Staff costs	£423.49
Line 6 Other payments	£414.37

While these discrepancies offset each other, it leaves an unreconciled difference of £17.

We recommend that the Council reviews its accounts and cashbook to ensure they are consistent and provides a full reconciliation to the Accounting Statement when requested for future audits.
